**AAUW Public Policy  
Update June 2011**

As the 2011 session of the Oregon Legislature moves into its final month, there are still many questions about how the final budget may affect the state's quality of life.

The K-12 public education budget, at \$5.7 billion, has been signed by the Governor. Since it is the largest single amount in the General Fund budget, it was important to get it settled early. Now the Joint Ways and Means committee is considering all of the state agency budgets, the next largest being the Department of Human Services, followed by Public Safety which includes Corrections and the Youth Authority. Under the newly adopted funding structure of this Assembly, it was determined that the required balanced budget only would reflect what the projected revenue for the biennium would be without any new taxes. The state's economic condition thus will result in severe cuts to basic services and programs.

The May revenue forecast from the Legislative Revenue Office, the state Economist and the Office of Economic Analysis, given May 12, indicated that personal income and the Lottery proceeds were up along with employment growth, but personal income tax receipts, the housing market

and withholding and other payments to the state were down. While 15,000 more persons are working, their actual wages are down. The final budget figure is arrived at using the May forecast, so while there was an increase of \$128 million in revenue for the General Fund, it doesn't solve the looming problems of protecting services for children and families, the disabled, the elderly, children at risk, and assisting local school districts with additional funding, as well as community colleges and four-year higher ed institutions. Financing the new Oregon Health Authority is also critical.

Throughout the session, AAUW's Public Policy team has been participating in the Revenue Coalition which is comprised of advocates for state services - education, health care, children and families, good government groups, etc. We have been encouraging the new Joint Tax Credits committee to carefully consider ending many of the tax credits which will expire in 2012. The Ways and Means Committee indicated it would like to have at least \$40 million in savings from those credits. There are other proposals to provide savings and increase the amount of money for the General Fund such as repealing the mortgage deductions for second homes, ending the political contribution credit, raising from 4.5 to 5 the ratio

of state employees to one manager where appropriate, cutting outside vendor contracts, and enacting an income-means test for the senior medical deduction – about \$350 million in savings. In this climate of raising fees and charges (nickel and dimes), several hundred million in savings would help save essential programs.

Although there seems to be a “no new taxes” concern, the Tobacco Free Coalition is making a strong pitch for a \$1 dollar per pack increase in the Oregon cigarette tax, one of the lowest in the country. Washington and five other states have raised their cigarette taxes this year. The results could bring in almost \$200 million the first two years, and would be expected to lower tobacco use by 10% over the next decade. The results are revenue increases plus better health for both young people and lowering costs of tobacco related diseases for adults.

Revising the kicker law and funding the Rainy Day and Educational Stability Funds are in limbo – at least for the public. The Senate Finance and Revenue Committee discussed, amended and voted unanimously to send three bills to the full Senate. The main measure was a constitutional amendment that would direct any personal income taxes surplus, above 2% of the projection, to a 50/50 split between the Rainy Day Fund

and a taxpayer credit. It would be voted on at the General Election in November 2012. The other two statutes would be enacted if the amendment passed. They would establish a Universities Stability Fund supported by any surplus above 2% of the projection in corporate income taxes, and cut the capital gains taxes. Instead of going to the Senate however, the Senate President sent the bills to the Senate Rules committee. We are waiting to see what happens.

This is the time in the session that bills that have not moved out of committee suddenly appear again with an entirely new proposal, except for the clause relating to Oregon laws. This process is called “gut and stuff,” and an interesting bill proposing more government transparency in campaign finance appeared May 19. It had been a proposal to limit campaign contributions. Now it would require that campaign ads for or against a candidate, not proposed by a candidate's committee, must have clear identification as to who is authorizing the leaflet, post card, TV or radio ad, and if a committee, the top three contributors to the committee. The bill had a very positive hearing and addresses an important issue of disclosure in campaigns. Other bills of interest include the bottle bill, with a 10 cents deposit increase, many more

types of bottles, and planning for regional redemption centers, that has passed out of the House and has a Senate hearing scheduled; the plastic bag ban at grocery check-out stands is stalled in Senate Rules and doesn't look promising; the toxic plastic sippy and baby bottles ban bill has passed the House; the Oregon Health Authority to develop programs to recruit medical school students, primary care residents, and primary care physicians has passed the House; the maternal mental health patient and provider education program within the Oregon Health Authority has passed the House; and full day kindergartens also has passed the House. All bills passed by one chamber need to have action within the next week or so to survive.

### **Chamber of Commerce Seeks Full Renewal of ESEA**

At odds with the Chamber of Commerce's traditional efforts, Margaret Spellings, senior advisor to the U.S. Chamber of Commerce, led the charge this week to renew and also [strengthen](#) the standards of the Elementary and Secondary Education Act. The White House and numerous legislators want to reauthorize ESEA but scale back on punishment for under-performing schools and give states more control.

AAUW [believes](#) it is possible—and necessary—to maintain a commitment to high standards and greater accountability in our nation's public schools. However, that commitment must be accompanied by federal support and financial assistance—such as by funding the Women's Educational Equity Act—to make it a reality.

### **Nine of Seventy-Two NAS Inductees Are Women**

The National Academy of Sciences recently announced the election of 72 new inductees, only nine of whom are [women](#). Among those criticizing NAS for not having enough women in its membership, the Association for Women in Science has produced [charts](#) demonstrating the disparity in percentages between women in science and women in NAS.

AAUW is [committed](#) to expanding and recognizing the role of women in STEM fields. AAUW's recent [report](#), *Why So Few? Women in Science*,

*Technology, Engineering, and Mathematics*, presents in-depth yet accessible profiles of eight key research findings that point to environmental and social barriers that continue to block women's participation and progress in science, technology, engineering, and math. 


