I heard discussions similar to what we have at our board meetings: projects, fundraising, and planning ahead. I picked up a couple of new ideas there. AAUW Public Policy Update May 2011

It's rather like the calm before the storm in Salem these days. The policy committees were frantically hearing bills and having work sessions on those that were to be moved forward before the deadline of April 21. Any proposal that was not heard, except in the Rules and Revenue committees, was literally dead after that date. Now both the House and Senate are acting on the bills referred to them. In Oregon, there can be no amendments on the floor so if legislators want a bill changed, it must be referred back to committee. Except for issues of taxation (3/5 vote) or constitutional amendments (2/3

vote), simple majorities are the only requirement for a bill to pass.

The revenue forecast on which the budget for 2011-13 will be based, will be presented to the Senate and House Revenue committees by the State Economist on May 12. Education, human services, and public safety are the three major programs funded by the General Fund, about 95 % of the total. The K-12 budget, at \$5.7 billion, has already passed the Assembly and been signed by the Governor. The other major funding is for human services, and large cuts are expected to services for the elderly, children and families, and the disabled. New health programs are being considered, but not totally funded. At-risk youth will have fewer services along with less dollars for corrections. With a \$60 million gap in the remaining two months of the 2009-11 biennium, and more than \$2 billion less than needed to continue current service levels, the Legislature faces some grim decisions.

There is significant discussion and disagreement about much should be taken from the two primary reserves – the Rainy Day Fund and the Educational Stability Fund. One group would keep at least \$450 million; another would keep only \$100 million. Already \$100 million was used to beef up the K-12 portion, and community colleges, and Eugene-Lane Branch--The News, May 2011 the four-year universities also need money. A special Tax Credits committee is reviewing all of the tax credits that sunset in 2012. In fact, the revenue forecast is built on the assumption that these will be "sunsetted." The Revenue Coalition, of which AAUW is a member, has been urging the Ways and Means committee and legislators in general to seriously consider the \$40 million to be saved in these tax credits. Also, we are requesting that a means test or cap be put on the Senior Medical deduction which would save about \$148 million; the deduction for the mortgage on a second home, and the ratio of manager staff to line staff, which could save \$71 million if cut from 5-to-1 to 4-to-1. There are others, and the total savings could amount to about \$500 million. There are too many "sacred cows" among the 350 or so tax expenditures (credits, deductions, exemptions and deferrals) that cost the state about \$27 billion in revenue every two years.

Redistricting for the 30 Senate and 60 House boundaries is beginning in earnest by the Senate and House Redistricting committees. They held joint hearings in 12 areas across the state during April, taking new population maps of each area for citizens to view. The mapping is being done by a GIS specialist, showing where the changes have occurred since 2001. Oregon has gone from 3.3 million to 3.8 people, a 12% growth. The growth is uneven, and the maps will show the census blocks (300-500 people) and census tracts (500-3000 people) and how they can be shifted. Important criteria include keeping the deviation between legislative districts as close to plus/minus 1 % as possible, ensuring fairness in diversity, avoiding division of natural barriers, keeping community of interest together, and avoiding consideration of incumbent legislators. AAUW will be monitoring the discussions, viewing the maps, and testifying as necessary. The committees have indicated there will be at least three public hearings on the proposed Plan. This may not be enough, and we, along with other groups, will press for additional public input. It must be passed and signed by the Governor by July 1. The Legislature is planning to adjourn by June 30. If the Assembly can't agree or the Governor vetoes the plan, the plan will be done by the Secretary of State (as in 1991 and 2001) by August 21 and then reviewed by the Supreme Court. It must be finished by December 31.

Some new election laws have been passed by the House and await discussion in Senate Rules. It is expected that the ban on BPA in sippy cups and baby bottles will pass, and that there will be changes in the bottle bill. A summary of some of the changes will appear in the June *News*, along with further information about the budget and the efforts to change the kicker law and add to the Rainy Day Fund. The contents of these bills change by the day, so by June much more will be settled. ************


Our Basketball Team*

EEOC Forum Examines Gender Pay Gap

On Thursday, the Equal **Employment Opportunity** Commission held a public forum at which two panels of experts discussed the longstanding problem of gender-based wage discrimination. AAUW Director of Public Policy and **Government Relations Lisa** Maatz served as a panelist alongside other prominent policymakers and specialists including the chair of the EEOC, the Deputy Director of the Office of Personnel Management, and the Director of the Women's Bureau at the U.S. Department of Labor.

Yesterday's forum was one of 24 events the EEOC is holding throughout April and May to raise awareness and educate the public on the problem of the pay gap.






