## AAUW Public Policy Update October 2011

A, The House and Senate Interim Revenue Committees met September 21 for the first time since the September General Fund revenue forecast on August 26 which projected a \$200 million shortfall for 2011-13. The purpose of this meeting was to lay out a work plan for the first annual session, February 1- March 6 2012.

Since the February meeting is short, the committee members were warned that the number of bills to be considered by the whole Legislature must be limited. Included for discussion in the Work Plans are as follows:

House Issues - Corporate taxes (cost of performance, kicker calculation); 911 tax base; property taxes and tribal property; Oegon's tax system and interstate competitiveness; local government finances (falling property values, timber payments); Reserve Fund policies/options.

Senate Issues - medical expenses and tax policy (impact of federal deduction threshold, senior deduction; all of the same House workplan discussion.

Potential 2012 Legislation: House: (1) modifications to senior and disabled tax deferral programs (HB 2543); (2) clarifications to Business Energy Tax Credits reform (HB 3672); (3) inclusion of prepaid telecommunications services in 911 tax base; (4) clarification of tribal property for tax purposes; (5) update connection to federal income tax code; (6) apply transient lodging taxes to residential care facilities (HB 2012); and (7) performance language for Dept. of Revenue system project.

Senate: working on the same legislation potentials as the House except for the transient lodging, tribal property and telecommunications.

These are significant issues, and the ability to address them completely and rationally over four weeks is certainly problematic. Among others with follow-up implications are estate tax reform, analysis of tax collections from Measures #66 and 67 (2010) and the impact of the Dept. of Revenue's tax compliance and tax collection policies.

B. Viewed by some as probably a rather dull hearing about a new elections law, instead there was a lively, impassioned discourse about PCPs in the House Interim Rules committee on September 21. The subject was a bill which died at the last minute of the 2011 session, HB 2492. Its purpose was to discontinue using the Primary Election ballot every two years to elect political party precinct committee persons (PCPs). For many years, the 36 county ballots have included space for the name or the opportunity to write in the name of a PCP for

all 17,244 Oregon precincts. The cost to county election departments across the state is approximately \$250,000 each election.

HB 2492 was scuttled in June with late objections by one political party, with the understanding that it would be discussed in the interim. Changing how precinct chairs are selected has been strongly supported by the Oregon **Association of County Clerks** (they run the elections) and the Task Force on Efficient and Effective Government. Invited to testify at the hearing were the clerks and representatives from the Republican and Democrat Central Committees. In its amended form, HB 2492 would eliminate write-in nominations, but would allow for a person's name to be on the ballot if there were more than one candidate for the position. Additionally, any one who filed as a PCP candidate with no opposition, would automatically be elected, but their name would not appear on the ballot.

The following data was presented by the clerks as testimony to both the difficulty and cost of including the PCP elections on the Primary ballot for all 17,244 possible PCPs:

- \* 3453 candidates filed for one of the positions
- \* 13,791 positions received at least one write in vote
- \* 1238 persons received enough (3) write-in votes to be elected

- \* 681 of those receiving enough votes accepted the position
- \* 37,352 the number of writein votes logged and tracked down by county clerks

The two Republican party representatives acknowledged the "relatively puny cost savings of changing the PCP election process, but strongly advocated for continuing the process because of its importance in encouraging new people enter into the political arena. They opposed any cut back. The Democrat representative recognized both the need to cut county election costs and to provide entry opportunities to party politics.He pointed out that HB 2492 provides both for some PCP elections and for appointments to the position. The Ds were not opposed to the bill.

The interesting part came when the committee co-chair allowed one of the Rs to give one last negative argument. This caused two Republican members of the Rules committee to question him sharply in disagreement that the discontinuance would lower opportunities for party participation and with the idea that saving local governments' dollars wasn't important. I would predict that the bill could make it to the floor this time

Budgets, education and health care, along with some environmental issues are among other interim committee discussions. They will all meet again in November to finalize the bills for 2012. The December Revenue forecast will be presented on November 19, and final requests for bill drafts have a December 5 deadline.

## **AAUW Signs Two New Amicus Briefs**

In March 2009, Quinnipiac University announced plans to cut three sports teams and to compensate for the lost opportunities by counting competitive cheerleading as a varsity sport. Members of the volleyball team and their coach filed a lawsuit, Biediger v. Quinnipiac University, and in 2010, the district court ruled that competitive cheerleading is not a sport under Title IX and that the university failed to provide equal athletic opportunities to its female students under the law. Ouinnipiac appealed the decision, and the case is before the 2nd U.S. Circuit Court of Appeals. AAUW signed a brief written by the National Women's Law Center to support the athletes in the case.






