AAUW Public Policy Update September 2011

The 2011 Session

Expectations for the 76th session of the Oregon Assembly, when it began in February, 2011, ran from dismal to chaotic. The House of Representatives was split (30-30) beween Democrats and Republicans; the Senate had the narrow margin of two Democrats (16-14). There was a \$3.5 billion deficit in projected revenue to provide for public services and programs. Unemployment in Oregon was still in double digits for many counties, and the housing market was continuing downward. Parts of the country were recovering

from the recession, but Oregon still seemed mired. Out of that scenario came the unexpected.

The House organized with joint party Speakers, joint cochairs for evenly divided committees, no bills moved forward without joint chair approval and relative public civility. The Senate elected a seasoned Democrat President, and each committee had a Democrat chair and Republican vice-chair. The Governor and the legislative leadership agreed to a new budget structure which called for spending no more than the projected revenue for the biennium, 2011-13, based on the December 2010 forecast, and keeping funds in reserve for the second year. While the cuts to state and local services were significant and harmful, some protections were given to the most vulnerable populations and K-12 schools. About \$500 million was kept in reserves to be considered for the 2012 first Annual session.

In the end, the session ended on the time set for adjournment, June 30; the budget was balanced as required by the Constitution; no great harm was done. There were citizen access issues such as many last-minute amendments not available, required email testimony submitted ahead of time, and obvious behindthe-scenes decision agreements. Of great help for the organization of the legislative session were the several interim committee planning and bill drafting

meetings held in May, September, and November 2010 and January 2011. Issues discussions and proposals formulated many of the measures. The number of bills prepared and hearings held didn't shrink much from prior sessions, but many fewer were passed. Among the critical areas not resolved were revison of the kicker law, stable funding for the reserve funds, increased funding for higher education, and additional changes to tax expenditures (credits, deductions, deferrals and exemptions).

Economic State of the State

The presentation by the state's economic advisors at the March revenue forecast on August 26 was fascinating (if you can use that term for such events). The first quarter of 2011 showed a strong recovery across both the U.S and Oregon, followed by a steep plunge for the second quarter which ended in June.

Instead of a slow, but sure steady increase in revenue and employment since April, Oregon now has a projected \$200 million General Fund loss for 2011-13. The analysts tried not to paint a too pessimistic future by showing that Oregon has not been as hard hit as most of the rest of the country by the sudden downturn. Personal income tax receipts and export revenues were slightly up, but corporate income tax receipts were significantly lower causing the lowering of the projected income for the

remainder of the two-year budget cycle.

The good news come from the prudent budget passed by the Legislature in June which has reserves to cover the revenue decline. The bad news is that additional funds for both social services and public schools scheduled for discussion at the February 2012 session may not be available. Depending on the December forecast, more reserves might have to be used to fill a continued decrease in revenue.

The Interim committees will start meeting in September (Sept. 21-23) to discuss issues for the first Annual session scheduled from February 1 to March 6, 2012. Meetings will also be held in November and January to draft and finalize bills. The deadline for submitting bill proposals to the Legislative Counsel is December 5, 2011. Some leadership and committee member changes have been made by both the Republican and Democrat caucuses. The legislative session will end just two months before the 2012 May Primary. It will be interesting to see what items will be in the forefront politically as Assembly members assess the elections' climate. Stay tuned!

June 2011 Report

AAUW Legal Advocacy Fund Accepts Two New Cases

In May, the AAUW Board of Directors voted to accept two new, important, and exciting cases, *Cioca v.*Rumsfeld and Gates and Parker v. Franklin County Community
School Corporation. AAUW is awarding them \$3,000 and \$4,200, respectively.

Board Votes to Disburse \$30,800 to Ongoing Cases

In May, the AAUW Board of Directors voted to contribute funds to five ongoing LAF cases. The board gave the Mansourian Title IX case the largest amount to help cover the plaintiffs' current trial costs.

AAUW Members Show Support at Mansourian Trial

Mansourian v. Regents of the University of California, a case LAF has supported for six years, just wrapped up a threeweek trial in federal court in Sacramento, California. More than a dozen AAUW members from the area attended. AAUW board member Alicia Hetman attended daily and hosted a potluck dinner for the plaintiffs and lawyers. Hetman said she arrived during Mansourian's testimony. "At lunch [Mansourian] told me that she was so happy when she saw me come in as it helped calm her down. ... I wish all AAUW members could feel the pride of hearing those kinds of comments from a litigant. It warms my heart and makes me dig deeper into my purse," said Hetman.






